

Privacy regulation and Cookie policy

General

This privacy regulation provides the user of the websites www.markadvocaten.nl and www.sportiefscheiden. nl with information on what data is processed by MARK Advocaten, and the purposes for which and way in which this data is processed. Through this website information is gathered on its visitors for marketing purposes and for the purpose of website optimization. MARK Advocaten respects the privacy of the users of its websites and will ensure that all information and personal data that is provided, is handled confidentially.

Privacy

MARK Advocaten will handle information and personal data obtained confidentially and with due care. Entering personal data is necessary for the purpose of responding to questions and requests for information or to register for mailings and newsletters. It is always possible to unsubscribe or submit a request to that effect through info@markadvocaten.nl. The permission of a parent or legal representative must be provided before personal data of visitors under the age of 16 is submitted through our website.

Links to other websites

Our website contains links to websites of third parties such as organizations with which we work together. The privacy regulation of third parties applies to the use of the websites of such third parties. MARK Advocaten is not liable for the way in which information and personal data is provided, processed or obtained during visits to the website of third parties.

Cookies

To enable visitors to its websites to use the full functionality of the websites, MARK Advocaten places small amounts of information (so-called cookies or similar technologies) on the device used by the visitor during the visit to a website, or MARK Advocaten reads information available in the browser settings of users. The cookies and similar technologies are also used for the purpose of analysis of the use of the websites referred to above, analysis of trends and navigation behavior. The information gathered is provided to Google Analytics. More information on the use of the information provided to Google is available in the privacy policy of Google Analytics. If you have given your permission for the use of such cookies our servers will store the data sent by your browser from your device to the server on which the information requested is stored. Server log files concerning these operations are kept. They contain information such as your web request, IP address and information of the browser. During the next visit to our website you will be recognized. This information is used to compile statistics and gain understanding of popular web pages and what other websites refer to our websites.

Social media

The websites of MARK Advocaten contain so-called media buttons of Facebook, Twitter and LinkedIn. By using these buttons the website visitor may decide to indicate to the media services referred to above through the website visitor's own social media account that one is interested in our services. The use of such social media is subject to the terms and conditions of the provider concerned. The privacy regulation of MARK Advocaten does expressly not apply to the use of such services.

Sharing with third parties

MARK Advocaten will share personal data with third parties in the following cases:

- If personal data is provided to (sub) processors for the purpose of performance of the services for which
 they have been engaged. In that case such third parties may process the data only according to the (sub)
 processing instructions of MARK Advocaten, and these parties are required to agree to processing such information according to our instructions and in accordance with this privacy regulation and other measures concerning confidentiality and security;
- If MARK Advocaten is convinced that processing, use, retention or disclosure of personal data is reasonably necessary in order to comply with statutory obligations and/or identify, prevent or otherwise handle fraud or technical security breaches;
- To protect the rights, ownership rights or the security of MARK Advocaten, its users and third parties from imminent threats, to the extent as permitted or required by law, or after the express approval of the holder of the rights.

Security of your data

MARK Advocaten takes the protection of data seriously and takes suitable precautions to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. Access to, modification of or erasure of data

You have the right to access, rectify or erase your personal data. In addition to that you have the right to withdraw your approval of data processing or to object to the processing of your personal data by MARK Advocaten, and you have the right to data portability. That means that you can request us to send your personal data that is stored by us, as a computer file to you or a different organization to be specified by you. You may submit a request for access, rectification, erasure or transfer of your personal data or a request for withdrawal of your permission or objection to the processing of your personal data to: info@markadvocaten.nl

In order to ascertain that your request for access is submitted by an authorized individual, we request you to attach to the request a copy of your ID. Please black out the passport photo, MRZ (machine readable zone, the section with numbers at the lower end of the page), passport number and Citizen Service Number ("Burgerservicenummer", "BSN") on this copy for the purpose of protection of privacy. MARK Advocaten will respond as quickly as possible but in any case, within four weeks of receipt of the request.
